I acknowledge that this is not ALL water but as I stated in my briefing .. the water use can relate to cabin use and hence the use of other amenities; roads, fire/emergency. I agree that at some point we may try to figure another way to distribute these costs. AND, that answers your second question .. we own the system but it costs to produce water and we are seeking a **fair way to distribute** those costs to the owners .. like a time share condo or a partnered airplane ownership. [as an aside ... State Law requires water meters .. much to the chagrin of many cities like Fresno & Modesto who have thousands of residences without meters]. Speaking of legalese .. we need a defensible billing structure in case someone wanted to make a stink .. we have a leg up being a 'membership' utility rather than a 'subscriber' type with Prop 218 elections ..


